PRIVACY POLICY SUPPLEMENT

For Residents of the European Union

The General Data Protection Regulation (the "GDPR") sets out obligations and rights with respect to the personal data of residents of the European Union. The Regina Exhibition Association Limited ("REAL") is committed to ensuring that it complies with the requirements of the GDPR. As such, this supplement to REAL's Privacy Policy outlines additional information relevant to residents of the European Union only. 1. Basis for Processing Personal Data

REAL processes personal data when it has a lawful basis to do so in accordance with the GDPR. Generally, this means that REAL processes your personal data only where you have provided consent, where necessary to provide you with services, or where necessary to comply with a legal obligation of REAL. REAL may also process your personal data where otherwise allowed by the GDPR for the authorized purposes outlined in REAL's Privacy Policy.

2. Your Rights relating to your Personal Data

Subject to some exceptions, the GDPR provides you with the following rights:

- a. <u>Right of access</u>: You have the right to information about whether and why we process your personal data and related information (for example, what personal data we are processing).
- b. <u>Right of rectification</u>: You have the right to correct any inaccurate or incomplete personal data that we hold about you.
- c. <u>Right to erasure</u>: You have the right to ask us to delete personal data that we hold about you.
- d. <u>Right to restrict or object to processing</u>: You have the right to ask us to limit or stop our processing of your personal data in certain cases (for example, if the personal data we are processing about you is inaccurate or is for direct marketing purposes).
- e. <u>Right to data portability</u>: You have the right to ask us for a copy of personal data we hold about you and to transfer such data to another entity.
- f. <u>Right to complain</u>: We encourage you to contact us at the contact information below if you have any questions or concerns with our personal data practices. However, you also have the right to complain to regulatory authorities in your jurisdiction. Please contact us at the contact information below if you need information about the appropriate authority.

3. Retention and Storage of Personal Data

REAL is based in Canada and processes personal data in Canada. The European Commission recognizes Canada as providing an adequate level of protection for personal data. REAL's service providers may process your personal information outside of Canada (such as in the United States of America). When your information is processed outside of the European Union, it may be subject to the laws of and be accessible by legal authorities in such other jurisdictions. REAL has taken appropriate technical, organizational, and legal steps to secure this information.
